

WHAT DO I NEED TO APPLY FOR MY THAILAND VISA?

TOURIST VISA:

Completed application form.

Original passport - must be valid for at least 6 months after planned departure from Thailand and must have two blank visa pages.

Two recent, colour, passport-sized photographs taken against white background and printed on standard photographic paper.

Proof of sufficient funds – 20000 Baht per person – approximately, €520 e.g bank statement in case of single entry visa request. Please note, in case of a multiple entry visa request, the bank statement should show a balance of at least £5,000 for the last 6 months.

Flight booking confirmation.

Accommodation booking confirmation.

Confirmation of legal residence in the UK or Ireland - residence permit or BRP card.

BUSINESS VISA:

Original passport, valid for at least 6 months beyond entry date with at least 2 blank visa pages.

Completed and signed visa application form.

Two recent, colour, passport-sized photographs.

Proof of sufficient funds – 20000 Baht per person – approximately €520 e.g bank statement.

Letter from current employer addressed to the Embassy on company letterhead paper, stating the applicant's name and including the following details: specify the purpose of the visit, the number of entries and the length of the visa required, the name of the organisation to be visited with its contact details. It must include an acceptance of financial responsibility for the applicant and it must be signed by the applicant's supervisor or company's HR Department.

Letter of invitation from the company in Thailand on company letterhead paper, stating the name of the applicant and the following details: the purpose of the visit, the number of entries and the length of the visa required. Confirmation of legal residence in the UK or Ireland - residence permit or BRP card.

Please note that the Thailand Embassy no longer accepts applications completed by hand, only applications submitted online are accepted. An appointment must also be booked with the embassy to submit applications. Visa First can assist with every stage of the application process, however delays may occur due to this new system.

Where should I send my documents to?

VISA FIRST, 14 St. Stephen's Green, Dublin 2, Ireland.

How long does the visa take to be organised?

The standard processing time is 5 working days.

How much time can I spend in Thailand?

The allowed stay on a tourist visa is up to 60 days per entry.

The allowed stay on a business visa is up to 90 days per entry.

How long is the visa valid for?

Tourist visas can be issued as either 3 month single entry or 6 month multiple entry visas. They are valid from the date of issue. Business visas can be issued as either 3 month single entry or 1 year multiple entry visas. They are also valid from the date of issue.

You must travel with the same passport you hold at time of completing this application. If you obtain a new passport after your visa has been issued, please contact the Visa First help desk for advice. In this case reallocation fees may apply.

Visa First advises against purchasing restricted or inflexible tickets prior to visa issuance. Processing times shown on this application are standard processing times. While Visa First makes every effort to ensure that visas are processed according to advertised timelines, Visa First does not accept any claims for delays caused by postal strikes or delayed post handling by postal companies or embassies which are outside of our control.

It is the client's own responsibility to ensure that they familiarize themselves with their visa validity dates and ensures all details on the visa are correct. The client must enter the country to activate the visa before the visa expiration date.
